## 79/24a Treasurers Report – Judy Leader

## **Main Points**

- October sees the start of the new financial year 2024/25.
- Income is attributable to the affiliation fees and entry for the Young Teams Relay Galas
- Expenditure is attributable to the regular outgoings (COL, Workspace, software etc) together with the BLC pool hire from Sept only invoiced this month (Masters & Inter Clubs) and the final Masters sundry expenses
- The invoice for the Long Course training that was held in August for National swimmers have been received (and paid) and is included in 2023/24 FY report.
- Stuart Sharp is in the process of his inspection and preparing the End of Year Accounts

#### 2024 Masters Meet

- The final invoices and expenses for the meet were received and paid.
- This brings the final surplus to £1758.67 a 76% increase on last year (less than was reported last month).

Judy said she was hopeful that she would receive the year end accounts from Stuart Sharp by the weekend. If there was a delay it may be that these would need to be circulated separately to the Annual Report. She did not envisage there being any issues.

## 79/24b: East Midland Region Report – Ursula Beck

The next Board meeting was due to take place on Saturday 16<sup>th</sup> November 2024. Helen informed the Executive that all clubs had received details regarding the suspension of Swim Mark which had been under review over the summer. Club Affiliation for all clubs would continue and Clubs would be expected to complete Club Affiliation instead of the full Swim Mark.

Judy asked whether this would impact on the County Governance process. Ursula said she would query this with Helen Weeks at Swim England.

Val queried whether the Swim England membership fees were now available as the Club was due to have a finance meeting this Thursday and would be setting any increase in fees at this time, dependent upon the membership fees required by Swim England. Ursula said nothing available as yet, but she would ask the question at the Board meeting this coming Saturday and get back to Val hopefully with the information.

#### 79/24c: Swimming Report – Paul Sippitt

In the absence of Paul, Geoff briefly went through the additional information for the Age Groups which had been circulated by Geoff to all Clubs. Ursula apologised for not having circulated this information prior to the meeting. It was confirmed that all information relating to the Age Groups was available on the LASA Website.

I have organised Referees, Starter & Chief Timekeeper to date. I am liaising with Geoff regarding the risk assessment.

Unfortunately, Market Harborough had missed the closing date for entering and Sue said it would not now be possible to add them as the programme had been completed. She stressed that all clubs had received several reminders, including at the Coaches meetings. Val said it had been assumed that the Head Coach was dealing with this.

## CHAIR/COACHES MEETING 12<sup>TH</sup> OCTOBER:

This was very well attended with only Melton and Coalville unable to send any representatives. A copy of the summary notes circulated after the meeting is attached.

Following the meeting the Memorandum of Understanding was circulated to those clubs where no one was able to sign on the day: Leicester Sharks, Coalville & Melton Mowbray

There are a few clubs where only one signature was obtained on the day and a second signature has now been obtained from Market Harborough & Leicester Neptune. Second signatures are still outstanding from Oadby & Wigston. Abi said she would have a word with Steve, Rachel and Ian for Coalville.

I have offered to go across to talk to the committee at Melton Mowbray as they have currently declined to sign the MOU; I am awaiting a response from their Chair.

The clubs were asked to respond to the paper discussed at the meeting regarding organising swim camps. It is extremely disappointing that only one club has responded to date (the requested date was 31<sup>st</sup> October). I will review

the ideas and consider whether alternative options should be looked at. Without full commitment from all clubs the camps would not be a viable option.

Ursula said it was disappointing that clubs were not responding to suggestions being made by Sue that would receive County support. The County could only offer swim camps and extra training facilities if clubs were prepared to support these.

Val confirmed that Market Harborough Swimming Pool was now up and running following the closure for the refurb of the Leisure Centre.

Our big focus for November was the Inter County Masters Competition held at the Sandwell Aquatics Pool Birmingham - today 10<sup>th</sup> November. 9 teams took part, and Leicestershire finished a really credible 4<sup>th</sup> place.

NB We were seeded to finish 4<sup>th</sup> and as this is where we came it shows how well Leicestershire performed in this event. (We look forward to seeing the overall results across the whole of England once published to compare with last year).

Our Leicestershire Masters Team consisted of 34 Masters swimmers covering all age groups.

The team spirit was fantastic and the effort which everyone gave was really pleasing.

I would like to thank all swimmers who took part – they were a credit to Leicestershire also their respective clubs and themselves.

Thanks also goes to our two Leicestershire Officials who gave up their Sunday afternoon to attend this event.

I would especially like to thank our Team managers on the pool deck - their presence really helped to keep our swimmers informed about their races and answer questions and advise their relay times - I am sure all swimmers appreciated their help.

I would especially like to mention my wife Yvonne and son Mathew for all their hard work supporting me behind the scenes and on the pool deck – they worked really hard to help everything happen, and I consider they deserve a special mention.

Our Next focus for Masters swimmers is the East Midlands Masters Championships on December 1<sup>st</sup> at Moorways Pool and also there is the popular Etwall Eagles Masters meet December 7<sup>th</sup> and both events involve a good number of Leicestershire Masters swimmers, and I hope they all do well

The new Leicestershire Banner had been taken to the Masters competition but a suitable place for it to be displayed could not be found. However, the new Pennant had been displayed. Alan confirmed that both the banner and pennant were now back in the LASA cupboard at Braunstone.

Alan also informed the meeting that Swim England were looking at the standard of Officials for Masters Meets as often time unlicenced volunteers would support the galas. It was pointed out that often time the Officials who normally volunteered for events were swimming themselves as Masters Swimmers. The concern from Swim England was that Masters swimmers were breaking records and there was a need to ensure that the correct process was being followed which should include fully trained officials. Alan said he would inform the meeting if he was given any further information.
